HIRER TO PRINT and RETAIN

Hirers are to enter into an agreement with Nobbys Surf Life Saving club Inc. (herein after referred to as the "Club") to be bound by the following rules and should read them carefully before signing an Agreement of Hire.

ALL FUNDS RAISED THROUGH THE HIRE OF THE SURF CLUB ARE UTILISED BY THE CLUB FOR THE BENEFIT OF THE HUNTER COMMUNITY. HIRERS ARE REMINDED THAT NOBBYS SLSC IS A NOT FOR PROFIT ORGANISATION.

1. BOOKINGS and BOND/DEPOSIT

- All hirers are requested to lodge a bond with the club, to be paid when submitting the "Agreement of Hire" form.
- The full amount of the bond will be returned to the hirer within 14 days of the function, provided that all the conditions contained in the "Rules of Hire" are complied with. In the case of any excess damage to the premises or excess cleaning during the course of the function, which exceeds the initial bond paid, the hirer will be issued with notice of the excess fees for damage.
- Tentative bookings are kept for a maximum of two [2] weeks from the date of the initial booking. Dates will once again become available after the two [2] weeks.

2. SMOKING

Nobbys SLSC is strictly a **Non-smoking** venue for all the interiors and within four [4] metres of the building entrance/s – **Smoking Laws 6 July 2015 Commercial Outdoor**. Smokers may use the great outdoors and **MUST** dispose of cigarette butts responsibly.

3. RESTRICTED FUNCTIONS

- The building may not be hired for any illegal purposes.
- 18th and 21st birthday parties including 'combined parties' are strictly for club members only and approval is at the discretion of the club. Refer to section 11 below.
- The building shall not be hired for any functions advertised over the internet or through social media.
- Nobbys SLSC retains the right to reject any application to the hire without providing a reason.

4. NUMBER of GUESTS

As a general rule, the club can accommodate up to 100 people seated at tables, or up to 140 people standing comfortably for such functions as cocktail style functions.

5. DURATION of FUNCTION

- All functions must have a set start and finish time at least one [1] week prior to the function as stated in the "Agreement of Hire"
- For all social functions, the rates of hire allow for 5 hours, plus 30 minutes for guests to leave the premises. An additional charge may be applied if guests have not vacated the premises within the allocated time.
- An additional charge of \$50 for club + \$30 per hour for bar staff applies every one [1] hour, or part thereof, above the five [5] hours if additional time is required. This must be organised at least one [1] week prior to the function.
- The latest time the club can be utilised is 11.00pm. The club is available for hire from Monday to Saturday.
- Meetings, conferences, seminars are subject to negotiation with the Club Hire Manager (herein after called the "MANAGER")

6. CLEANING & DECORATING

The cost for cleaning the club is included in the hire costs. The Hirer is required to observe the following:

- 1) Cleaning fee is not negotiable.
- 2) Whatever the hirer brings onto the premises must be removed at the end of the function, unless otherwise organised with the Manager. Nobbys SLSC is not responsible for private property left on the premises before, during or after a private function.
- 3) The club cleaner is only responsible for cleaning toilets, floors, bar/kitchen area and general cleaning of the surf club grounds.
- 4) All excess garbage must be removed at the end of the function.
- 5) An extra charge will be incurred if the function centre cleaner has to clean glasses, remove table decorations/cloths, remove chair covers etc. This will be charged at an hourly rate.
- 6) Use of the following is **NOT PERMITTED**: drawing pins, sticky tape, nails and adhesive materials to display signs or attach decorations. Limited use of Blu-tack is permitted.
- 7) The kitchen is only to be used for the preparation of food and must be left in a clean and tidy condition at the end of the function.

7. SECURITY

- All hirers are responsible for the behaviour of their guests. They must ensure that only invited guests are admitted to their function.
- If a person is refused service, under the Responsible Service of Alcohol Laws, that person **MUST** leave the premises immediately and it will be the Hirers responsibility to ensure this is carried out.
- If club bar staff is not used during the hire, it is the hirers' responsibility to turn off all lights and lock the club.

8. CLUB BAR and SERVING of ALCOHOL at PRIVATE FUNCTIONS

- The Club's Licensee is directly responsible for ensuring that all laws relating to the **Responsible Service of Alcohol** are adhered to (see Nobbys SLSC Alcohol Management Policy for further details).
- Unconsumed alcohol, if provided by the hirer, remains the property of the Hirer, however at the agreed closing time of the function, it shall be secured by the bar staff in the clubs cool room for collection by 9:00am the following day.
- No alcohol is to be taken away at the end of the function due to the **Responsible Service of Alcohol laws**.
- Alcohol may only be consumed within the club hall. Alcohol must **NOT** be taken out of the club doors, the main entrance, onto the car park, into surrounding parkland or the beach.

- Under the **Responsible Service of Alcohol laws**, the clubs' bar staff has the right to refuse service to any guest if deemed necessary.
- If a person is refused service, under the **Responsible Service of Alcohol laws**, that person **MUST** leave the premises immediately and it will be the Hirers responsibility to ensure this is carried out.
- "Last drinks" will be called 30 minutes prior to the agreed finish time of the function, with the bar closing 15 minutes prior to the agreed finish time.
- All music to cease 15 minutes prior to the agreed finish time.

9. HIRED EQUIPMENT

- All hired equipment delivery and removal is the sole responsibility of the Hirer. Storage of certain equipment after the function may not be possible due to other bookings.
- Equipment can be delivered and removed from the club between the hours of 9:00am and 4:00pm Monday to Saturday. If removal is required on a Sunday, arrangements must be made with the Club Hire Manager.
- The use of candles or other open flame devices is strictly prohibited in accordance with Fire Regulations. Please contact the Club Hire Manager for these guidelines.

10. FUNCTION CENTRE EQUIPMENT and SETUP AVAILABILITY

- The Club Hire includes the use of the club, 100 chairs, 10 rectangular tables with a length of 1.8m, the kitchen area and the use of the bar as described in Section 8 above.
- The Club is available between the hours of 9:00am and 4:00pm Monday to Saturday for function setup. The club is available one [1] day prior to the date of the function **ONLY** if there is no other function being held on the previous day.

11. 18th and 21st BIRTHDAY PARTIES – BY EXCEPTION/SPECIAL RULES

The club reserves the right to reject an application for the hire and also cease immediately an ongoing function, if the Hirer is unprepared to meet any of the following requirements:

- 1) The Hirer must be a financial club member and be able to demonstrate that there is a strong surf club connection with family or members in attendance for the duration of the function.
- 2) The Hirer must be able to demonstrate that there is a strong family involvement with parents and other family members in attendance for the duration of the function.
- 3) A maximum of 100 guests, by formal invitation only, and no "open", "word of mouth" or "word of web" invitations.
- 4) The Hirer is to employ Professional Security guards for the duration of the function with a ratio of one [1] security guard per 50 guests.

12. PRICES

The club reserves the right to review fees and charges at any time.

13. PAYMENT of BOND/DEPOSIT

- To confirm a booking, please deposit your \$200 bond/deposit via EFT to Nobbys SLSC - BSB 637-000, A/C 780 320 265, putting 'CLUB HIRE + Surname' in the description field.
- The club hire fees **MUST** be paid in full one [1] week prior to the commencement of the function.

14. FUNCTION CANCELLATION

- 1) A cancellation fee will be charged based on the following:
 - Outside of 3 months prior to the function – NO cancellation fee
 - Within 3 months prior to the function - \$50 cancellation fee
 - Within 2 months prior to the function - \$100 cancellation fee
 - Within 1 month prior to the function - loss of bond/deposit
- 2) The cancellation fee will be taken from the bond/deposit and the remaining money, if any, shall be returned via EFT.
